Permanent Secretaries and Heads of Departments are hereby advised that approval is given for the Fixed Motor Car Allowance which is paid to the officers in the positions listed on the attached schedule to be increased from the existing rate of \$341,220 per annum to revised rates as set out below;

- > \$477,708 per annum with effect from April 1, 2006.
- > \$568,812 per annum with effect from April 1, 2007.

An officer who operates a partially maintained Government Motor Car should be paid 50% of the above rates, that is;

- > \$238,854 per annum with effect from April 1, 2006, then
- > \$284,406 per annum with effect from April 1, 2007.

Please also be advised that an officer holding the specified post to which the motor car allowance is attached but who does not possess a motor vehicle is to receive an allowance as set out below;

- > \$191,088 per annum with effect from April 1, 2006.
- > \$227,520 per annum with effect from April 1, 2007.

Officers in receipt of these fixed rates for Motor Car allowance are not eligible for mileage or kilometer rates.

Payment of the new rates may be made in October 2006 and the retroactive amounts from April 1, 2006 are payable in December 2006. Costing for payment of arrears should be submitted to the Ministry of Finance and Planning (Public Expenditure Division) so that the appropriate allocations may be made to various Heads of Estimates.
