To: Permanent Secretaries Heads of Department

Permanent Secretaries and Heads of Departments are hereby advised that approval is given for the Motor Car Allowance which is paid to the officers in the positions listed on the attached schedule to be increased from the existing rate of \$568,812 per annum to the revised rate as set out below:

• \$796,500 per annum with effect from April 1, 2008

An officer who operates a partially maintained Government Motor Car should be paid 50% of the above rate, that is;

• \$398,250 per annum with effect from April 1, 2008

Please also be advised that an officer holding the specified post to which the motor car allowance is attached but who does not possess a motor vehicle is to receive an allowance as set out below;

• \$318,600 per annum with effect from April 1, 2008.

Please note that Officers in receipt of Allowances as listed below will become eligible to claim for mileage with effect from September 1, 2008 provided that they have travelled a minimum of 200km per month (calendar month).

- Officers in receipt of Motor Car Allowance
- 50% Allowance for Partially Maintained Motor Car

Payment of the new rates and retroactive amounts may be made in September 2008. Costing for payment of arrears should be submitted to the Ministry of Finance and the Public Service (Public Expenditure Division) so that the appropriate allocations may be made to various Heads of Estimates.

This Circular supersedes Circular No.38 MOF&P#11301 Vol. VI dated September 14, 2006.
