Re: Clarification to Circular No. 1 Reference 107/125 Dated January 6, 2010 - Salary Lodgement And Authorised Deductions

The attention of Permanent Secretaries, Chief Executive Officers and Heads of Departments is invited to the following clarification in respect of the captioned Circular:-

- 1. The non-refundable processing fee does not apply to credit unions, people's cooperative banks, insurance companies, thrift societies, pensions and superannuation funds. It applies to the entities listed in the attached document. Please note that the attached list is not exhaustive. The non- refundable processing fee will apply to any new entity that is added to the list by Bank of Jamaica or the Financial Services Commission.
- 2. The non-refundable processing fee of \$500.00 where applicable must be paid by the employee requiring the standing order deduction.
- 3. The non-refundable processing fee of \$500.00 is to be charged as a one off payment for new irrevocable standing orders from approved financial institutions. Variations to the standing orders shall not attract a processing fee.
- 4. The processing fees collected must be paid over to the Accountant General as Miscellaneous Revenue in the case of Ministries, Departments and Executive Agencies.
