Tertiary Grant for Children of Public Sector Workers

Reference is made to Item 6.24 of the Heads of Agreement signed on February 13, 2018 between the Government of Jamaica and the Jamaica Confederation of Trade Unions (JCTU) representing certain Public Sector Workers for the 2017 - 2021 contract period for the continuation of the tertiary grant to children of Public Sector Workers.

Applications are now invited and **should be submitted by June 30** noting the following guidelines:

- 1. The grant:
 - a. Is to assist with the payment of tuition fees only.
 - b. Covers eighty percent (80%) of tuition up to a maximum of one hundred and fifty thousand dollars (\$150,000)
 - c. May be awarded to an applicant once every three (3) years.
- 2. The grant is applicable to Public Sector Workers who are:
 - a. Permanently appointed or temporary with at least two (2) years' service.
 - b. Contract workers with at least two (2) years continuous service under any type of contract, i.e. 1yr recurring, 2yrs or other.
 - c. Not employed to an entity or is a member of a bargaining unit that has similar educational assistance.
 - d. Not recipient of any other Government of Jamaica educational grant.
- 3. The grant is applicable to children of public sector workers who:
 - a. Have been accepted to pursue <u>or</u> are pursuing **local, full-time accredited programmes** (Associate/Bachelors) at a tertiary institution registered by the University Council of Jamaica.
 - b. Have a **minimum GPA of 3.0** (for continuing students)
 - c. Are not older than 25 years
 - d. Are unemployed.

- 4. The following documents **must** be submitted along with the application:
 - a. Applicant's Employment Letter
 - b. Acceptance letter for new students. A Provisional/conditional acceptance letter may be submitted, however, a copy of full acceptance is required before the Grant is disbursed.
 - c. Progress Report for continuing students
 - d. Copy of the **child's Birth Certificate**, certified by HR Department, reflecting the name of the parent making the application
 - e. Tuition cost for the Programme of Study (a print-out from the Institution's website will suffice).
- 5. All applications *must be*:
 - a. Submitted using the attached form (updated March 2016) which is also accessible at <u>www.mof.gov.jm</u>
 - b. Certified by the Human Resource Department (HRD) or the Head of the Department (in instances where there is no HRD). Incomplete and late applications will not be processed and will be returned to the organisation.
 - c. Must be submitted <u>through</u> the Human Resource Department of the respective Ministry/Department/Agency to the:

- 6. Union and Staff Association Representatives may submit applications on behalf of members once requirements 5(a) and (b) have been met.
- 7. Applicants should note that the award of the Grant is subject to the availability of funds, consequently not all eligible applicants will be awarded..
- 8. Payment will be made directly to the institution on the award of the Grant. Where the institution has indicated that payment of tuition has already been made the award will be withdrawn.
