# **#BuildBackBetterTogether - Exploring Government and citizen partnership in Jamaica's COVID-19 recovery**

Governments around the world are grappling with the ongoing public health, economic and psychological damage from the COVID-19 pandemic. The compound nature of the pandemic has required governments to develop and deploy new capabilities under constraints of great uncertainty and significant pressure. Creating space for learning and reflection in this context is a challenging, but necessary, part of mounting an effective response.

The Open Government Partnership (OGP)<sup>1</sup> has sought to address this challenge by documenting the trends and practices emerging among its member countries, and facilitating knowledge sharing. Arising from this discourse is strong evidence affirming that the most successful government responses have employed openness—transparency, accountability and participation—as a core implementing principle. Openness manifests in modalities ranging from clear and effective risk communication and community engagement; transparency in the implementation of fiscal stimulus and the process for accessing social safety nets; and at times, humility when new information or mistakes result in a change to strategy. The terms that have emerged in the OGP community to describe these practices are "Open Recovery" and "Open Response".<sup>2</sup>

Open Recovery and Open Response are approaches to emergency response that place transparency, accountability and participation at the centre of COVID-19 containment, provision of emergency response, and medium-term government efforts to rebuild in the wake of the pandemic. The Jamaican Government has implemented many open approaches in its COVID-19 response. These include the regular press briefings by the Prime Minister and Ministry of Health, transparent implementation and communication surrounding the COVID-19 Allocation of Resources for Employees (CARE) Programme, and the establishment of public-private working groups ("task forces") to examine the re-opening of the economy.

To create an opportunity for reflection and knowledge sharing, the OGP Jamaica Civil Society Working Group will be hosting a #BuildingBackBetterTogether webinar and discussion on Open Recovery + Response. The topics to be discussed include:

- Innovative Open Recovery + Response activities being implemented across the globe and early lessons from these experiences.
- How the GOJ has used openness in its own approach to COVID-19.
- Existing and upcoming entry points for citizens to contribute to or participate in Jamaica's COVID-19 response, and exploring the areas that we can strengthen
