### Scholarships for Public Officers

Reference is made to Public Sector Negotiation Framework Item No. 7.2.4.5, approved by Cabinet Decision No. 24/17 dated 12 June 2017 Section (B)(i), in respect of Scholarships for Public Officers.

Applications are invited for the above-mentioned Scholarship noting the following guidelines:

1. The Scholarship:
  - a. *Is to provide financial assistance to Public Sector Workers in pursuit of their educational goals and professional/personal development for Academic Year 2025/2026.*
  - b. *Covers tuition cost only up to One Hundred and Fifty Thousand Dollars (\$150,000.00).*
  - c. *Application is available via an **Online Application Form** – which can be accessed on the Ministry's website [www.mof.gov.jm/scholarships](http://www.mof.gov.jm/scholarships).*
2. The Scholarship is applicable to Public Sector Workers who are:
  - a. *Permanently appointed or temporary with at least two (2) years' continuous service.*
  - b. *Newly accepted students at a registered recognised Institution.*
  - c. *Returning students, previously enrolled at a registered recognised Institution with at least a B Average (i.e. GPA 2.5 or higher).*
  - d. *Indebted to a registered recognised Institution having completed a programme of study within the past academic year (2024/2025).*
  - e. *Not employed to an entity or are members of a bargaining unit that has similar educational assistance.*
  - f. *Not recipients of any other scholarship/financial assistance/grant processed through the Government of Jamaica/Ministry of Finance and the Public Service (MoFPS) for Academic Year 2025/2026.*
  - g. *Not on interdiction.*
3. Programmes/Levels Supported:
  - a. *Any programme (local/regional) that is recognised/accredited by the University Council of Jamaica (UCJ) at the Undergraduate or Post-Graduate Level. Pursuit of studies at a level already attained will not be supported.*
  - b. *Certification – must be offered by an Institution authorised to offer the certification*
  - c. *CSEC & CAPE Subjects.*
  - d. *Studies may be done by attendance onsite, distance (online) or a combination of both.*
4. Applicants **should**:
  - a. *Download and print the Verification Form which is accessible at [www.mof.gov.jm/scholarships](http://www.mof.gov.jm/scholarships)*
  - b. *Have their Human Resource Department (HRD) or equivalent complete the Verification Form and check the required documents.*

- c. Complete application details via the **Online Application Form** which is accessible at [www.mof.gov.jm/scholarships](http://www.mof.gov.jm/scholarships), and submit the application **only once**.
  - d. Scan and email supporting documents (outlined below) to [mou.grants@gmail.com](mailto:mou.grants@gmail.com) using the applicant's TRN and Name in the subject heading - eg. 123-456-789 John Doe.
5. The following supporting documents **must** be submitted along with the Online Application Form (see Item 4d):
  - a. Duly completed **Verification Form**
  - b. **Taxpayer Registration Number (TRN)**
  - c. Applicant's **Job Letter** (salary particulars not required) addressed to:

  - d. **Official Acceptance Letter for new students.** A provisional/conditional acceptance letter may be submitted, however, a copy of full acceptance is required before the Scholarship is disbursed.
  - e. **Progress Report/Transcript for returning students (minimum B Average/2.5 GPA).**
  - f. **Proof of Tuition Cost/Balance Owing to Institution for the programme of study.** A print-out from the Institution's website – specific to the programme - is acceptable.
  - g. **Where applicable, Letter of Award from MDA** in respect of study leave awarded to the applicant for the current programme of study.
6. The Online Application Form **opens Monday, July 14, 2025 and closes Friday, August 29, 2025 at 5:00pm. Incomplete applications will NOT be processed.**
7. **Applicants should note that the award of the Scholarship is subject to the availability of funds, consequently not all eligible applicants will be awarded.**
8. *Payment will be made directly to the Institution. Where the Institution has indicated that payment of tuition has already been covered, the award will be withdrawn.*
