**Government Employees Administrative Services Only (GEASO) Health Scheme
Increased Benefits and Premium – August 1, 2026**

Sagicor Life Jamaica Limited continues to administer the provision of Administrative Services for the Government Employees' Administrative Services Only (GEASO) Health Scheme.

The benefits to subscribers will be revised with effect from August 1, 2026 and are set out on the attached schedule (appendix 1). There will be increases to the subscription rates as indicated in the table below:

The following are to be noted:

1. The monthly subscriptions are prepaid; hence, **the revised monthly subscriptions must take effect July 1, 2026 as deductions from July's payroll provide for August's coverage.**
2. All monthly payments must be sent to the GEASO bank account via electronic transfer by the 5th working day after the deduction has been made.
3. The new Excel Summary Form (appendix 2) (which highlights all additions, terminations, transfers and plan changes) **must** be completed and submitted electronically along with the monthly deduction listings to Sagicor Life Jamaica Limited at slj_geaso@sagicor.com and copied to the Ministry of Finance and the Public Service (MOFPS) at geasomof@mof.gov.jm by the 5th working day after the deduction.
4. The MOFPS will continue to pay the employer's portion of the subscriptions once payment has been made to Sagicor by the pay site.
5. Each pay site is to ensure that its subscribers submit their commercial banking information to Sagicor Life Jamaica Limited through the Human Resource Departments, utilising the **Subscriber Change Request Form** (appendix 3) before **September 30, 2026.**
6. Claim reimbursements will be made **via Electronic Fund Transfer (EFT) only.**
