

Editorial

The Ministry of Finance and the Public Service (MOFPS) marks the start of a new year with renewed energy and a steadfast commitment to advancing Jamaica's economic growth, public sector transformation and national resilience. The past year has shown us that even through difficult times we remain committed to managing the nation's socio-economic and financial policies as we strive to build a resilient Jamaica.

In October 2025, Hon. Fayval Williams, MP, CFA, Minister of Finance and the Public Service, represented Jamaica at the Financial Action Task Force (FATF) Regional Body Jurisdictions Guest Initiative. Joining Kenya and Nigeria, Jamaica's participation under its own flag highlighted the country's growing role in shaping international policy on anti-money laundering and counter-financing of terrorism, while demonstrating global recognition of our progress.

In addition, the Government of Jamaica (GOJ) through the MOFPS also continued its efforts to support Jamaica's recovery following the passage of Hurricane Melissa that has severely impacted the western belt of the island. Customs relief measures were implemented to facilitate the ongoing rebuilding process, demonstrating the GOJ's commitment to enabling swift recovery and resilience-building across affected communities. Complementing these measures, the Finance Minister met with the Caribbean Catastrophe Risk Insurance Facility team to discuss further support for Jamaica's post-hurricane recovery, underscoring the importance of strategic partnerships in enhancing national resilience.

HARD STOP DATE OF JANUARY 15, 2026 FOR THE RELIEF OF IMPORT DUTY AND GENERAL CONSUMPTION TAX AS A RESULT OF HURRICANE MELISSA



Press Release Dated: Wednesday, December 31, 2025.

Reference is made to the Ministry of Finance and the Public Service Press Release of November 6, 2025 regarding the relief of customs duty and general consumption tax (GCT) on a specified list of items.

The Government of Jamaica wholeheartedly thanks all those who responded to the devastation of the Category 5 Hurricane Melissa in Jamaica with the outpouring of relief supplies. We are grateful for the many efforts in cash and/or kind. This has helped families and Jamaica's relief effort significantly.

We understand that due to the Christmas season and the intervening holidays, the capacity of shippers, freight forwarders, brokers and the ports were significantly constrained. As a result, some donors may not have had their donations arrive on or before December 31, 2025, which is the cut-off date for relief of import duty and GCT upon importation of selected items. As such, the Government of Jamaica is extending the period of relief to **January 15, 2026**. This date will be a hard stop.

While the Government of Jamaica welcomes the gifts and donations, the decline in tax revenues at Customs since Hurricane Melissa has been significant, totaling approximately **JMD \$12 billion.**

As Jamaica transits from the relief phase to recovery & reconstruction, we ask our friends and families abroad to help by utilising the normal channels for items sent to Jamaica for relatives and friends as **the January 15, 2026 deadline is a hard stop with respect to the relief of import duty and GCT that was provided as a result of Hurricane Melissa.**




FINANCE MINISTER ATTENDS FATF REGIONAL BODY JURISDICTIONS GUEST INITIATIVE

Hon. Fayval Williams, MP, CFA, Minister of Finance and the Public Service attended the Financial Action Task Force (FATF) Regional Body Jurisdictions Guest Initiative in October 2025. The Plenary welcomed Jamaica and Nigeria as new participants, joining Kenya under the initiative. Through this mechanism, guest jurisdictions participate under their own flag at FATF

meetings, strengthening cohesion of the Global Network and broaden regional perspectives at FATF meetings. Minister Williams highlighted that the invitation reflected the international community's ongoing recognition of Jamaica's progress and an opportunity for Jamaica to contribute to global policy direction on anti-money laundering and counter-financing of terrorism.






The Planning Institute of Jamaica (PIOJ) introduces the Multidimensional Poverty Index (MPI) — a revolutionary tool that expands how poverty is measured and support provided for individuals.

How Does The MPI Measure Poverty?

The MPI measures poverty across four equally weighted dimensions, using 15 specific indicators:



An individual is identified as multidimensionally poor if he or she is deprived in 40% or more of the total indicators.



JAMAICA'S NEW POVERTY MEASURE GOES BEYOND MONEY

This approach uses the same data source as monetary poverty, enabling a deeper understanding and more precise delivery of interventions. The MPI identifies the specific, combined deprivations a person experiences, providing the data needed for precise, impactful interventions.

Why The MPI Matters?

The MPI is a key instrument in the National Poverty Reduction Programme (NPRP) and a resource for development partners. It targets social programmes more effectively, directing resources where they are needed most and identifies and tracks deprivations across regions and sectors over time. The MPI monitors poverty reduction efforts and supports Vision 2030 Jamaica alignment.

FID AND UWI MONA LAUNCH FUNDAMENTALS OF COUNTERING FINANCIAL CRIME CERTIFICATE PROGRAMME

Hon. Fayval Williams, MP, CFA, Minister of Finance and the Public Service delivered remarks at the launch of the Fundamentals of Countering Financial Crime Certificate Programme held at the UWI Mona Campus on Monday, December 8, 2025.

The Programme is a collaborative effort between the Financial Investigations Division and the University of the West Indies, Mona that targets professionals in law enforcement and persons with an interest in law enforcement and financial crime.

Minister Williams in her remarks said, 'This programme is the first of its kind in the region, as prior to this all certification in financial crimes needed to be done outside the region. The course will start on January 6, 2026 with the first cohort of 30 persons, which is 5 persons from each participating law enforcement agency."

ALL PROCURING ENTITIES NOW MANDATED TO PUBLISH DETAILS OF EMERGENCY CONTRACTS



Press Release Dated: Tuesday, December 9, 2025.

The Government of Jamaica (GOJ) has introduced a new requirement for procuring entities to publicly disclose contracts awarded in situations of emergency or extreme urgency on the Government of Jamaica Electronic Procurement (GOJEP) system at www.gojep.gov.jm. This new requirement reinforces the GOJ's commitment to transparency, accountability and public oversight.

Pursuant to the Public Procurement (Amendment) Act, 2025, all procuring entities are now required to publish Emergency Contract Award Notices within one month of the date of award. The measure ensures that Jamaicans can see how public funds are spent during emergencies and why fast-tracked procurement decisions are made.

The requirement for publication of emergency contract notices on the GOJEP system became effective on Wednesday, November 12, 2025.

While emergencies often require swift action, the Government emphasises that speed must not come at the expense of transparency. This new requirement allows the public to view what goods, works and/or services are being procured, who is receiving the contracts and the justification for the award, even in times of crisis.

Each Emergency Contract Award Notice is required to provide clear and essential details to ensure full public accountability. At a minimum, the published notice must include the name of the contract, the name of the contractor(s) along with the justification for their selection, the date the contract was awarded, the total value of the contract, the duration and current status of engagement, a description of the emergency or extreme urgency that necessitated the procurement and a summary of the goods, works, or services procured.

This new publication requirement strengthens the Government's commitment to transparency, integrity, accountability, fairness and value for money in public procurement. By centralising all emergency contract awards on the GOJEP, the Government is ensuring that the public, civil society and the media have early and equal access to information, helping to build greater trust and confidence in how urgent public spending decisions are made.

For further guidance and support, both procuring entities and members of the public can access Guidance Note 2 of 2025 – Procurement in Situations of Emergency or Extreme Urgency on the Office of Public Procurement Policy website at www.procureja.gov.jm. This guidance provides detailed information on the rules governing emergency procurement in Jamaica.
