he Ministry of Finance and the Public Service (MOFPS) kicked off the 2023/24 National Budget Secondary School Tour at Wolmer's Trust High School for Girls on Tuesday, April 18, 2023.

The inaugural session saw students and staff of Wolmer's Boys and Girls Schools benefiting from a deep dive into the government's expenditure for the financial year.

The launch also dissected the 2023/24 Citizens' Guide to the Budget and sets in motion a series of 10 workshops geared at sensitising secondary school students in the corporate area. The presentations likewise explored the role and functions of the Ministry.



Hon. Nigel Clarke, DPhil., MP, Minister of Finance and the Public Service, highlighted the Ministry's stride to ensure the national budget is easily understood among all Jamaicans.

"The National Budget Secondary School Tour is an initiative of the Ministry of Finance and the Public Service to make the national budget more accessible to Jamaicans. It follows other similar initiatives such as the annual Citizens' Guide to the Budget," says Minister Clarke.

He further added, "Information is the lifeblood of a democracy. We hope to empower Jamaican citizens through the democratisation of budgetary information and by so doing strengthen the health and vibrancy of our country."

This grass root approach is a part of the Ministry's push to inform and engage young Jamaicans about things of national impact.

Meanwhile, Hon. Fayval Williams, MP, Minister of Education and Youth commended the MOFPS for spearheading the initiative and implored students to take advantage of the information being shared.

"This was an awesome session, I am very impressed with the participation and the quality of questions coming from our students. I want to thank the Ministry of Finance and the Public Service for this initiative; to raise awareness about the national budget among our students," Minister Williams said.

She also emphasised, "All our children need to understand the national budget, what it means to them in their own lives and the lives of their communities as well, so I welcome and embrace this initiative."

In the meantime, Dwight Pennycooke, Principal of Wolmer's Boys, said this initiative is changing the understanding of the national budget.

"This is an excellent initiative geared at garnering understanding and the fact that the Ministry of Finance and the Public Service would have seen it fit to start with students, I think will be a game changer in terms of people understanding the national budget and how it impacts on their lives and their livelihood," he said.

Diamonique Brown, Head Girl for Wolmer's Girls, said, "The session was very informative, it tied in a lot of aspects of budget planning and aspects of our economy that a lot of persons might not be familiar with and it was really exciting to see the young girls and gentlemen answering the questions to the best of their abilities."

"As we're going into the workforce... In a few years this will be us so we need to understand the national budget... even if we're not necessarily going into finance, the budget and economy still affect everyone so it's important for all of us to know the different aspects," added Brown.

Over 250 students were present at the launch which included an outside broadcast on ZIP103 FM.

The school tour will make stops at St. Hugh's High School for Girls, Clan Carthy, Excelsior, Camperdown, Denham Town, St. George's College and Jamaica College. It will culminate on Friday, April 28, 2023, at Holy Childhood High.

The topics to be explored during the tour include understanding where the money comes from to fund the budget, parts of the national budget, how funds are allocated and Public Debt, among other areas.

The presentations will be conducted by members of the Ministry's Corporate Communication and Public Relations Branch and the Fiscal Policy Management Branch.



# STATEMENT FROM THE MINISTER ON CENTURY ALUMINUM COMPANY'S ACQUISITION OF 55% INTEREST IN JAMALCO FROM NOBLE GROUP

he Government of Jamaica (GOJ) notes the announcement from Century Aluminium Company ("Century") about its transaction with the Noble Group ("Noble") with respect to Noble's 55% interest in JAMALCO. The GOJ offers its non-objection to the transaction and welcomes Century as the new managing partner of JAMALCO. The GOJ looks forward to working with Century to maximise the value of JAMALCO for all stakeholders.

In November 2021 JAMALCO experienced a fire which engulfed the power plant, halting production at the plant for almost a year before partial production resumed on a single digester basis in August 2022. In order to restore the refinery to its rated capacity of 1.4 million tonnes a series of further investments, referred to as Project Restore, are required. With the transfer of Noble's share-ownership to Century, the necessary investments are expected to be made, in association with Clarendon Alumina Production ("CAP") to improve JAMALCO's operating efficiency and to restore the facility to a top place among the top two quartiles of the global ranking of alumina producers.



Furthermore, Century is aligned with the GOJ on the priority of transitioning JAMALCO from an unincorporated joint venture legal structure arrangement to a limited liability company structure. These efforts will therefore continue and are expected to gain increased momentum and achieve completion.

#### **About Century Aluminium Company**

Century Aluminium Company is a global producer of primary aluminium, operating smelters in the United States and Ireland. The company operates three aluminium smelters in the US, Hawesville and Sebres in Kentucky and Mount Holly in South Carolina, and another smelter, Grundartangi, in Iceland. These smelters produce standard grade and value-added primary aluminium products that are used in aerospace, automotive, building and construction, packaging and infrastructure industries.

The company is listed on the NASDAQ exchange, with approximately 45% of its shares held by global metals company, Glencore.

Century has been one of the largest customers of the JAMALCO refinery and alumina produced by JAMALCO has been used in all its smelters. The acquisition of the 55% ownership in JAMALCO is expected to assure Century of a predictable, long-term supply of high-quality alumina, allowing for efficiencies associated with vertical integration from bauxite

#### **About JAMALCO**



# IFC JOINS THE GOVERNMENT OF JAMAICA TO DISCUSS THE COUNTRY'S PPP PROJECTS AND OPPORTUNITIES

#### Press Release dated: Tuesday, May 2, 2023

igh-level representatives from the International Finance Corporation (IFC)—a member of the World Bank Group (WBG)—participated in a symposium with the Government of Jamaica to discuss the country's Public-Private Partnerships (PPP) program, including projects in the urban transportation, roads, healthcare and water.

With opening remarks from the Minister of Finance and the Public Service of Jamaica, Dr. Nigel Clarke and the IFC Vice President for Europe, Latin America and the Caribbean, Alfonso García Mora, the first day of the symposium included presentations by the Jamaican Government authorities and discussions on market perspectives, as well as sector-specific opportunities. The event will continue tomorrow with further conversations about projects and the next steps.

"This symposium is a crucial step towards advancing Jamaica's PPP agenda, and the Government of Jamaica looks forward to more fruitful discussions with key stakeholders, such as IFC, to drive growth and development in the country," said Minister Clarke.

"Jamaica is a priority country for IFC, and we are pleased to be a partner concerning PPPs, particularly as the Government has demonstrated enormous leadership in advancing this agenda," said García Mora in the context of his first visit to the Caribbean as IFC Regional Vice President.

Last year, during the Annual Meetings of the International Monetary Fund and the World Bank Group, Minister Clarke and IFC Managing Director Makhtar Diop signed a Financial Advisory Services Agreement for the development of the North Coast Highway Project, which has an investment value of approximately US\$600 million. As part of this engagement, IFC is committed to providing transaction

advisory services to the Government of Jamaica and structuring and implementing a competitive tender process to mobilize a private operator that will design, build, finance, and operate three brownfield roads.

As part of another PPP engagement, in 2016 IFC was the transaction advisor for the successful 25-year concession of the

Norman Manley Airport in Kingston.

## MOFPS HOSTS PUBLIC CONSULTATION ON NATIONAL NATURAL DISASTER RISK FINANCING POLICY

he Ministry of Finance and the Public Service (MOFPS) is set to engage thousands of Jamaicans in a series of public consultation fora on the Government of Jamaica's (GOJ's) National Natural Disaster Risk Financing (NNDRF) Policy starting at the Old Police Station (50 Main Street) May Pen, Clarendon on Monday, May 15, 2023, from 4:00 p.m. to 8:00 p.m.

The NNDRF Policy is the GOJ's guide to disaster risk financing, aimed at minimising the fiscal impact of disasters on the national budget, the economy and society. It also serves to ultimately enhance the country's economic resilience to natural disasters.

The first of four sessions, which will give average Jamaicans an opportunity to voice their opinion, concerns and questions on the policy, will feature an outside broadcast on Irie FM and will include a live performance from recording artist, Agent Sasco.

Trevor Anderson, Principal Director of the Fiscal Policy Management Branch says the policy acts as an insurance coverage for Jamaica in the case of natural hazards including weather events and earthquakes.

He added, "The advent of this policy is a game changer for the National Budget, as the risk of significant slippages, arising from a natural disaster, has been mitigated through the use of financing instruments".

Anderson further noted that "Disasters such as Hurricane Gilbert in 1988, not only resulted in loss of lives and property, it also negatively impacted the fiscal accounts, resulting in a higher debt burden."



With such disasters at the forefront of the policy, it will serve as a tool to address deficiencies in how the budget responds to the impact of natural disasters as well as promote a risk-layering approach to Disaster Risk Financing (DRF) that facilitates access by the GOJ to one or several pools of resources based on the severity of the natural disaster.

In addition, to building financial and disaster risk resilience, the policy also addresses the budgeting process for disaster risk financing as well as building institutional capacity for disaster risk financing.

The ministry is set to host public consultation sessions at William Grant Park, Downtown Kingston on Wednesday,

May 17, 2023, with an outside broadcast on ZIP103 FM and in Sam Sharpe Square, St. James on Wednesday, May 24, 2023, with an outside broadcast on Mello FM and a performance from recording artist Laalee

Additionally, the public consultation sessions will culminate on Friday, May 26, 2023, in Mandella Park, Half Way Tree, St. Andrew with an outside broadcast on Edge 105 FM and a performance from recording artist Laalee. All sessions will commence from 4:00 p.m. to 8:00 p.m.

This NNDRF Policy represents Jamaica's enhanced financial resilience with respect to addressing the aftermath of natural disasters.

he Government of Jamaica (GOJ) is doubling down on its mandate to strengthen the governance and accountability system of public bodies through the launch of the Ministry of Finance and the Public Service's (MOFPS) Public Bodies Database of Prospective Directors at the Jamaica Pegasus Hotel on Thursday, May 18, 2023.



The database will contain information on persons willing to serve on public body boards. This means a due diligence check would have determined that persons possess the requisite knowledge, skills and experience to be selected and appointed to a public body board.

Additionally, the database will facilitate greater probity, efficiency, and transparency, as well as an organised and structured approach to the process for nominating, selecting and appointing persons to the boards of Jamaica's public bodies.

Hon. Nigel Clarke, DPhil., MP, Minister of Finance and the Public says the database is revolutionary and is

the Government of Jamaica's commitment to public sector reform and good governance.

He further noted, "There will come a time when we say that the database is now ready and at that time persons will not be able to be appointed to the board of public bodies if they are not included prior to the time of appointment in the database."

In the meantime, Camille Facey, Chair of the Private Sector Organisation of Jamaica (PSOJ) underscored the importance of the database and the impact it will have in making the selection process more efficient.

"It is in our interest that they [public bodies] be overseen by competent boards comprised of directors who are fit and proper and of the highest integrity with the requisite skill sets to add value to the organisations."

The database forms part of the Public Bodies Management and Accountability Regulations which affords an organised and structured approach to the process of nominating, selecting and appointing persons to the boards of Jamaica's public bodies.

## REFORM AND MODERNISATION OF GCT AND EXCISE IN JAMAICA - PHASE 2



he Ministry of Finance and the Public Service in collaboration with the Tax Administration, Jamaica (TAJ) hosted high-level discussions with the heads of the World Bank, the Organization for Economic Co-operation and Development (OECD) and the Irish Revenue between Monday, June 12, 2023, and Thursday, June 15, 2023. The 4-day mission represents phase-2 of the reform and modernisation of the GCT and Excise in Jamaica as phase-1 was previously executed in January 2023.

The mission commenced with a detailed presentation of a report which included, policy, legislative, administrative, cross-cutting issues and policy formulation, along with analysis and recommendations. There were also recommendations on improving the efficacy and equity of the appeals process and dissemination of appeal decisions. The team also focused on strategies to address motor vehicle compliance.

The last 2 days of the mission comprised workshops surrounding modern excise management practices, interagency cooperation and developing a real-time track and trace system for excise control. A new Excise Duty Act, developing a Risk Analysis Strategy for GCT including the use of new technologies and Tax Administration code, digital transformation and IT Governance structures among others, were also dissected.

The members of the mission were, Elena Bondarenko, David O'Sullivan, Philip Brennan, Gioia de Nelo and Silver Namunane from the World Bank, Thomas Ecker from OECD and Duncan Cleary, Michael Daly and Justin Walsh from the Irish Revenue.





## 1,250 SCHOLARSHIPS FOR MATH AND SCIENCE TEACHERS

The Government of Jamaica is providing 1,250 scholarships through The Mico University College for Jamaicans preparing to become a science, technology, engineering and mathematics teachers under a \$2.5 billion-dollar Science, Technology, Engineering and Mathematics (STEM) Scholarship Programme. The main aim of this programme, which runs over five years, is to produce qualified, technically proficient, work-ready STEM Teachers for the Jamaican education system.

The scholarship programme, which was launched on Thursday, June 29, 2023, at the Courtyard by Marriott in Kingston, is a partnership between the Ministry of Finance and the Public Service (MOFPS), Students' Loan Bureau (SLB) and The Mico University College (MUC).

Hon. Nigel Clarke, DPhil., MP, Minister of Finance and the Public Service announced the programme during his 2023/2024 National Budget presentation earlier this year. The recipients of the scholarship will fulfil the GOJ bonding criteria, which helps guarantee that they will teach in our public school system for a defined period.

While delivering his remarks at the launch, Minister Clarke said the STEM scholarship programme forms part of the Government's efforts to make Jamaica's workforce globally competitive.

"We are making this national investment in

math and science teachers as part of the drive to improve STEM education outcomes which is critical for the expansion of our growth and development opportunities. This all begins with having sufficient numbers of well-trained math and science teachers who are already in high demand. We, therefore, hope to increase the supply of math and science teachers through this scholarship initiative," said Minister Clarke.

Dr. Asburn Pinnock, President of The MUC mentioned that this programme will give the education system a big boost in supporting teacher education excellence through the provision of financial resources to teachers to complete their studies.

"One of the greatest hindrances for the movement is lack of resources and tuition and so I can see that this is going to be a game changer for parents, guardians and those who support our students as they move towards satisfying their real-life dream," he highlighted.

Meanwhile, Nikeisha Walsh, Executive Director of the SLB revealed that SLB will not only facilitate payments of scholarships but will be providing additional benefits through their own STEM programme.

"These students can benefit from a reduced interest rate of 6% per annum and are also eligible for good standing benefits of an additional 2% reduction in interest once they maintain a GPA of 2.5 and greater as well as current status during repayment."




## READ ACROSS JAMAICA DAY
