GOJ TABLES 1.26 TRILLION DOLLAR BUDGET

Hon. Fayval Williams, MP, Minister of Finance and the Public Service delivered the 2025 Opening Budget Presentation in the House of Representatives on Tuesday, March 11. She outlined how the Government of Jamaica plans to spend its 1.26 trillion-dollar budget in the upcoming fiscal year.

The Central Government Expenditure Budget of J\$ 1.26 trillion dollars comprises:

- Non-Debt Expenditure of approximately J\$917.8 billion
- Debt Service of approximately J\$340.3 billion

Non-Debt Expenditure, in turn is comprised of:

- Compensation of Employees J\$495.8 billion; Recurrent Programmes J\$27.8 billion; and
- Capital Expenditure J\$62.6 billion.



The presentation highlighted the following for the upcoming fiscal year:

- The J\$495.8 billion for Compensation of Employees includes provision for new rates of pay for: Medical Consultants, Dental Surgeons, Parish Court Judges and Probation/Aftercare officers; back pay for Medical Consultants and Parish Court Judges; an allocation to support the employment of agriculture wardens.
- \$1.0 billion to support continuation of the Jamaica National Service Corps;
- Compensation Contingency Provision of \$33.0 billion to meet the cost of public sector wage settlements
- Provision of support to filling vacant technical positions of \$3.0 billion in Regional Health Authorities.
- Effective April 2025, the GCT threshold will be increased from \$10 million to \$15 million dollars.
- For the upcoming September 2025, the government through the Students' Loan Bureau will be offering new students a longer payment period of 10 years, instead of the current 7 and 5 years.
- The PAYE threshold will increase in 3 tranches, effective April 1, 2025, it will increase to \$1.8 million dollars, then \$1.9 million dollars in 2026 and \$2 million dollars in 2027.

The government has allocated \$1 billion dollars to assist the first 20,000 first time JPS pre-paid customers who sign up for prepaid electricity. The first 20,000 new prepaid customers will get \$4000 credit for electricity per month under the GOJ House Wiring and Inspection Program that will be implemented by JSIF.



The Finance Minister announced plans to have a tax office opened in every parish on a Saturday.

Ministry of Health and Wellness

\$10.2 billion is allocated for MOHW, including \$5.0 billion for Cornwall Regional Hospital and \$4.1 billion for the IDB supported Prevention and Care Management of Non-Communicable Diseases (i.e work on the Spanish Town Hospital)

Ministry of Labour and Social Security

• \$2.1 billion of which \$1.1 billion is allocated to provide individual grants of \$20,000.



Office of the Prime Minister

\$4.6 billion is allocated to the OPM including \$3.0 billion for the National Identification System.

Ministry of Science, Energy, Telecommunications and Transport

\$4.5 billion is allocated for MSETT, including
3.2 billion for the procurement of new buses for the JUTC.

Ministry of Education, Skills, Youth and Information

\$4.2 billion is allocated for Education, including
 \$1.7 billion to the Primary and Secondary
 Schools Infrastructure Programme.

Ministry of Agriculture Fisheries and Mining

 \$3.7 billion is allocated for MOAFM, including a total of \$2.2 billion for the Essex Valley and Southern Plains irrigation projects.

FINANCE MINISTER UPDATES THE NATION ON TAJ'S SPECIAL SETTLEMENT PROGRAMME

Hon. Fayval Williams, MP, Minister of Finance and the Public Service provided an update on the Tax Administration Jamaica's Special Arrears Settlement Programme during a Post Cabinet Press Briefing held at the Office of the Prime Minister on Wednesday, February 19, 2025.

The programme provides an opportunity for all persons and businesses, whether self-employed, company or organisations, to clear their debts, without the additional costs typically associated with late filing and payments related to several tax types and become compliant.



When entering Jamaica, you **MUST declare** any amounts exceeding **US\$10,000*** in cash or in any other form.



With limited exceptions, **DO NOT** pay/receive any amounts exceeding J\$1,000,000* in cash.



FITCH AFFIRMS JAMAICA'S RATING AT 'BB-' WITH THE OUTLOOK REMAINING POSITIVE

Press Release Dated: Monday, February 24, 2025.

Fitch Ratings Agency, on February 21, 2025, affirmed the Government of Jamaica's Long-Term Foreign-Currency Issuer Default Rating (IDR) at 'BB-', with the outlook remaining "Positive".

According to Fitch's press release, the rating affirmation is underpinned by the Government's "strong governance, significant progress with debt reduction, sound fiscal framework and strong commitment to deliver large primary surpluses."



The Agency noted that while weatherrelated events impacted the economy, Jamaica is expected to realize a projected primary surplus of 5.0 percent for FY2024/25, due in part to the proactive disaster risk financing policy, which facilitated a one-off payment from the Caribbean Catastrophe Risk Insurance Facility (CCRIF).

Fitch anticipates that debt-to-GDP will remain on a downward trajectory, inline to meet the target of 60.0 percent or less by FY2027/28. There have also been noted improvements in Jamaica's external position, with official international reserves increasing by approximately US\$900.0 million to US\$5.6 billion at the end of 2024.

In commenting on the rating action, Minister of Finance and the Public Service, the Honourable Fayval Williams, said, "I am more than pleased to know that international rating agency, Fitch, has affirmed Jamaica's rating at BB- with a continued positive outlook.

Despite all the negative weather-related shocks to the economy, Fitch recognizes that the government remains steadfast in its commitment to meet the 60% debt/GDP target which is the primary anchor for the fiscal policy being pursued by the Government. The Rating and Positive Outlook affirmations are significant for Jamaica."

relating to the handling of your dividend or interest payment.

THERE ARE THREE TYPES OF MANDATE:

BANK MANDATE

The investor indicates which financial institution their payment should be forwarded to. The information required are:

- a. Bank name
- b. Bank Branch
- c. Account Number
- d. Account type
- e. Account currency
- f. Name(s) on account

HOLD MANDATE

The investor may wish that their dividend or interest payment is held at the Registrar's office for collection

.

THIRD PARTY MANDATE

The investor may wish to send their dividend or interest payment to someone other than the parties on the account. For example, a charity or a church.

Whenever there is a dividend payment, the mandate information is forwarded to the Registrar so that they can follow the investors' instructions accordingly.


