Hurricane Dean Recovery and Reconstruction

1. A preliminary estimate of the damage and loss arising from the passage of Hurricane Dean on August 19, 2007 indicates \$23 billion of which \$16 billion was incurred by the private sector and \$7 billion by the public sector.

The areas identified as the most severely affected were the:

- 2. In the aftermath of the hurricane, the Government took a decision to provide \$2,000 to each of the 91,000 families enrolled in the Programme for Advancement through Health and Education (PATH) for a total of \$182 million that has already been disbursed. Assistance was also extended to National Insurance Fund (NIF) pensioners with the provision of \$5,000 each. Please note that the NIF assistance does not impact the Central Government's budget.
- 3. Relief efforts were assisted through the provision of funds for recurrent expenditure in the categories of:

4. The Ministry of Labour and Social Security, which has responsibility for welfare damage assessment among affected households, conducted an all island survey immediately following the hurricane. The results of the assessment are that approximately 44,000 households suffered some degree of damage. Of this number, 47% of the homes incurred minor damage, 45% major damage and 8% were totally destroyed. The housing stock in the southern parishes of Clarendon, St Catherine, Kingston, St Andrew, St Thomas and

Manchester were the most severely affected. It is proposed that relief of up to \$1.0 billion be provided to the housing sector. The modality under which the Government's contribution to the reconstruction of the housing sector will be outlined by the Office of National Reconstruction (ONR).

- 5. The Ministry of Agriculture estimates that direct damage to the farming sector is in the region of \$3.7 billion. The Government will provide direct assistance to the sector of \$260 million, the details of which are given below:
 - \$100 million Fertilizer Relief Fund
 - \$50 million Fruit Tree Crop Assistance Programme
 - \$10 million Banana Relief Assistance
 - \$25 million Coffee Sub-sector
 - \$10 million Fisheries Sector
 - \$10 million Seeds
 - \$20 million Greenhouse
 - \$35 million Land preparation for 3,000 hectares of land

Funds have already been released for the purchase of fertilizer.

6. Damage to the Transport and Works sector is estimated at \$2,256 million. During fiscal year 2007/08 the Government will provide \$490million for hurricane relief works in the sector. The proposal is broken down as:

- 7. The Ministry of Education estimates damage to the sector at \$773 million. The Government will contribute \$558 million to reconstruction activity in the sector during 2007/08.
- 8. Of the estimated \$300 million in damage to public buildings, the Government intends to provide \$150 million in 2007/08 for the repair of public buildings.
- 9. Government's total contribution to the recovery and reconstruction effort for fiscal year 2007/08 is expected to be \$2,645 million, which is summarized below:

FUNDING FOR HURRICANE DEAN RECOVERY AND RECONSTRUCTION

- 10. A number of sources have been proposed for financing of the recovery and reconstruction activity arising as a result of Hurricane Dean. They may be categorized under the broad headings of multilateral grants, bilateral grants, multilateral loans, bilateral loans, local grants and local loans. It should be noted that if the financing source is a grant, then the associated expenditure will not impact the fiscal deficit. However, if the source is a loan, the expenditure financed will further increase the fiscal deficit.
- 11. The Government is actively pursuing grant assistance from bilateral and multilateral sources through diplomatic channels, utilizing the damage assessment report prepared by the Planning Institute of Jamaica (PIOJ) as the base document around which the donors may commit. This report will shortly be tabled in Parliament.

- 12. Three multilaterals have indicated their willingness to provide emergency loans to assist in the reconstruction. These are the Inter-American Development Bank, the World Bank and the Caribbean Development Bank. The approval process for these loans is expected to be relatively short. Disbursement of the loans could be within five to nine weeks of the signing of agreements.
- 13. Concessional loans from bilateral sources also represents an avenue for financing the Hurricane Dean recovery and reconstruction effort and this is also being approached through diplomatic channels. The Government will also seek additional grant funding from local institutions.
