1. Upgrade and Strengthen the Open Data System in Jamaica

Replace "On a global scale, Open Data has become a major initiative by governments to increase the usefulness of research, information and data, encouraging government transparency, private sector technology growth, innovation and policy formulation."

With: On a global scale, Open Data has become a major initiative by governments to increase the availability and useability of information and data generated to facilitate research, and promote government transparency, private sector technology growth, innovation and policy formulation. Accepted replacement in revised commitment, with highlighted amendment.

Replace: "form" with "format" and "areas" with "subjects". Accepted replacements in revised commitment.

2. Increase Access to Information on and Public Awareness of the Justice System and Human Rights

Replace: "There are low levels of awareness generally among stakeholders and the general public on human rights, freedoms and responsibilities of citizens, including as provided in the Charter of Fundamental Rights and Freedoms in the Jamaican Constitution and the Universal Declaration of Human Rights. This leads to low levels of recognizing when human rights violations take place. There are also constraints in the existing sources of

information on the justice system in Jamaica, including the limited functionality, relevance and effectiveness of the existing Ministry of Justice laws of Jamaica webpage, significant information gaps on the existing webpage, and backlogs in the upload of new legislation and legislative changes."

With: "The mandate of the Ministry of Justice centers on the provision of policy support and analysis on justice issues as well as support to the maintenance of an efficient and fair system of justice which is accessible to all; the promotion of respect for rights and freedoms, the rule of law and the Constitution and the promotion of and awareness of individual responsibilities and civil obligations. In discharging this mandate the Ministry of Justice is championing an ambitious justice reform program geared to enable effective and efficient responses to challenges within the sector and is leading the process of modernizing the institutions, administration and operations of sector institutions. Within this context, the Ministry's public interface centres on a commitment to deliver justice for all by creating an enabling environment through a mix of policy, legislation, human and capital resources and services to yield an increase in access to justice outcomes and services. Access to justice is a critical pillar for sustainable development and the achievement of social and economic development and an increase in access to justice services is viewed as critical to the Ministry's mandate. However access to justice remains a complex issue characterized by economic, social, structural, cultural and institutional barriers, including citizen disengagement, the intricacy and cost of legal processes, as well as the need to deepen partnerships across Government. This also includes the unique challenge which flows from low levels of awareness among stakeholders and the general public on human rights, freedoms and responsibilities of citizens, including as provided in the Charter of Fundamental Rights and Freedoms in the Jamaican Constitution and the Universal Declaration of Human Rights. (See for example Jamaica Citizen Scorecard). To date this has led to a failure to translate and apply human rights concepts reflected in documented failures in recognizing when human rights violations take place. There are also constraints in the existing sources of information on the justice system in Jamaica, including the limited functionality, relevance and effectiveness of the existing Ministry of Justice laws of Jamaica webpage, significant information gaps on the existing webpage, and backlogs in the upload of new legislation and legislative changes."

## 3. Overall OGP NAP

Overall feedback on the OGP NAP was received from Erica Harris, Director, Information Technology Strategy Unit, MOFPS in January 2022. Feedback includes broad revisions based on style and presentation recommendations. The broad revisions were not included, as they did not affect the substance and content of the OGP NAP. However, some limited revisions based on style and presentation recommendations were accepted and included.
