First Progress Report on Status of Implementation

January - December 2022

Prepared by: Ministry of Finance and the Public Service (MOFPS)

1. Background and Context

This is the first public progress report on the implementation of Jamaica's first National Action Plan (NAP) under the Open Government Partnership (OGP) process. The NAP was submitted to the OGP in December 2021 and is being implemented over the period from January 2022 – August 2023. This first public progress report covers the period January – December 2022, and discusses the progress made toward implementing the seven (7) commitments in the OGP NAP during this reporting period. The progress report has been prepared in line with the reporting requirements of the OPG process by the Ministry of Finance and the Public Service (MOFPS), as the lead ministry for the OGP process in Jamaica, and reviewed by the OGP Multi-Stakeholder Forum (MSF), based on information provided on the status of the seven (7) commitments in the OGP NAP by each of the six (6) implementing ministries and agencies of the Government of Jamaica (GOJ), as follows:

It is important to note that the timeframes reflected in this progress report for commitments and milestone activities are the revised timeframes in the revised OGP NAP which was approved by Cabinet and submitted to the OGP in June 2022. In response to stakeholder feedback received, a new milestone activity was added to each of the OGP commitments to Upgrade and Strengthen the Open Data System in Jamaica and to Update and Implement the Climate Change Policy Framework respectively, which were also approved by Cabinet in June 2022, and are included in this progress report.

2. Highlights of Progress

The progress report on the OGP NAP indicates that progress is underway on all seven (7) commitments during the January – December 2022 review period, as highlighted below:

2.1 Complete National Anti-Corruption Strategy

The Evaluation Report on the consultancy bids which were received for the National Anti-Corruption Strategy (NAS) has been completed for submission to the internal Procurement Committee of the Integrity Commission for its review. The Evaluation Committee concluded its review by April 1, 2022 and the Evaluation Report on the bids which were received for the National Anti-Corruption Strategy will be submitted to the internal Procurement Committee for its review and approval in keeping with the GOJ rules. However, following the review of bids received, it was concluded that the second attempt at the procurement for a Consultant which commenced in January 2022 had failed to yield any positive results and, consequently, the procurement process was ended in June 2022. Subsequently, the Integrity Commission has taken the decision to move forward with the development of the NAS without the aid of a consultant, and is developing the internal roadmap to initiate the full execution of the NAS.

2.2 Upgrade and Strengthen the Open Data System in Jamaica

Work on the technical aspects relating to the demand survey and the mapping of data sets has taken place, in preparation for the consultancy for the upgrading of the Open Data Portal. Meetings of the OGP technical planning group for Open Data took place during June 2022, to develop the draft TOR for the consultancy to upgrade the Open Data Portal. The Terms of Reference (TORs) for the consultancy(ies) to undertake the upgrading of the Open Data Portal and supporting activities in two (2) Lots were completed in September 2022. The advertisements for Request for Expressions of Interest were published on September 11, 2022, and the period for responses was extended to October 6, 2022. Following the evaluation of the responses to the Request for Expressions of Interest (EOI) for consultancy(ies) to support the upgrading of the Open Data Portal and related activities, the shortlisted candidate for Lot 1 decided to withdraw from the process. The TOR for Lot 1 was subsequently revised to seek an individual consultant to undertake the demand survey and dataset mapping exercises. The Request for Proposals (RFP) was sent to the shortlisted candidate for Lot 2 in December 2022.

2.3 <u>Amend the Access to Information (ATI) Act and Strengthen the ATI System in Jamaica</u>

The establishment of a new Joint Select Committee (JSC) of Parliament has been proposed by OPM, to receive and review submissions by stakeholders on the proposed amendment of the ATI Act. A draft Cabinet Submission on the proposed establishment of the new JSC of Parliament has been prepared by OPM. Planning and preparation for virtual workshops for ATI Responsible Officers was advanced.

2.4 <u>Increase Access to Information on and Public Awareness of the Justice System and Human Rights</u>

Procurement for the establishment of the Jamaica Legal Information Portal (JLIP) is underway under the Foundations for Competitiveness and Growth (FCGP) project using

World Bank (WB) procurement rules. Terms of Reference for consultant has been approved and went to tender. The technical specifications for equipment procurement have been completed. The Request for Proposals (RFP) for the Lead Developer/IT Consultant for the JLIP has been finalized. The JLIP Portal project is at the point of procurement of equipment and selection of service providers. The bid process was initiated in October 2022 with the issue of the RFP. Bids have been received and are to be evaluated. Scanning of documents is also underway, including past issues of the Jamaica Gazette and the Laws of Jamaica, for future uploading when the JLIP is operational.

2.5 Complete Environmental Impact Assessment (EIA) Regulations

The updated preliminary drafting instructions for the EIA regulations were received by MEGJC from the National Environment and Planning Agency (NEPA) in late March 2022. An internal review of the preliminary drafting instructions was conducted in April 2022, and MEGJC sent comments on the updated preliminary drafting instructions to NEPA in May 2022.

2.6 Update and Implement the Climate Change Policy Framework

The stakeholder and public consultations on the Green Paper for the updating of the Climate Change Policy Framework were completed online over the period from November 2021 – February 2022. Amendments are being made to the updated Climate Change Policy Framework (Green Paper) based on the feedback received in the stakeholder and public consultations.

2.7 Strengthen Youth Participation and Access to Services

Preliminary steps are underway by MOEY for most of the activities under the commitment to strengthen youth participation and access to services. A Research, Monitoring and Evaluation manager for the Youth and Adolescents Policy Division of MOEY has been recruited as of the start of September 2022, and a draft Monitoring and Evaluation Framework for the National Youth Policy is expected by the end of FY 2022/23. Draft Terms of Reference (TORs) have been developed for the Intersectoral Technical Working Group and letters of invitation to representatives to serve on the group have been drafted. The survey of youth programmes and services across the public sector, private sector and civil society for the National Youth Programmatic Inventory was launched in September 2022, with a projected completion date of September 30, 2022. The first round of data collection from youth-serving organizations has been completed. The introduction and background to the report are being drafted. The contract with JIS to upgrade the website of the Youth and Adolescents Policy Division (YAPD) is underway, and a site map for the website is being developed. The prototype and layout have been developed and the process for the migration of data is underway. It is anticipated that the website should be at a 50% completion by March 2023.

A detailed report on the progress made and implementation status for each milestone activity under the seven (7) commitments in the OGP NAP is provided in Table 1 below.

3. Key Issues and Challenges by Commitment

However, a number of activities are already delayed based on the progress reporting, with a common theme of constraints in human resources and funding impacting their timely implementation. The following is a summary of the current key issues and challenges for timely implementation of each of the seven (7) commitments in Jamaica's first OGP NAP.

3.1 Complete National Anti-Corruption Strategy

Following the successive failures of two attempts to procure a consultant to support the development of the National Anti-Corruption Strategy, the key issue will be the capacity of the Integrity Commission to develop the NAS based on its own internal resources.

3.2 Upgrade and Strengthen the Open Data System in Jamaica

Letters of invitation for the re-engagement of the Open Data Committee under the new Open Data Policy were drafted and sent to the GOJ representatives. However the reconvening of the Open Data Committee was delayed beyond June 2022, with the committee holding its first meeting in August 2022. The role and modalities of participation of non-GOJ representatives on the Open Data Committee are being reviewed.

3.3 <u>Amend the Access to Information (ATI) Act and Strengthen the ATI System in</u> Jamaica

Human resource challenges have been identified for the activities relating to the preparation of improved guidelines for public bodies and ATI officers, conducting a programme of public education on the ATI system and rights, and development of proposal for the application of technology for online platform for making and tracking ATI requests.

3.4 <u>Increase Access to Information on and Public Awareness of the Justice System and Human Rights</u>

The activities relating to the Human Rights and Justice Public Education Programme have been delayed due to resource constraints.

3.5 Complete Environmental Impact Assessment (EIA) Regulations

Staffing constraints in the Environment and Risk Management Branch, MEGJC, have led to delays in executing the activities for this commitment.

3.6 Update and Implement the Climate Change Policy Framework

Staffing constraints in the Environment and Risk Management Branch, MEGJC, have led to delays in executing the activities for this commitment.

3.7 <u>Strengthen Youth Participation and Access to Services</u>

There have been delays in designing the M&E Framework to support the Implementation Plan for the National Youth Policy due to staffing constraints in the Youth and Adolescents Policy Division of MOEY.

4. Dashboard of Milestone Activity Implementation Status

The status of implementation of the milestone activities for each of the seven (7) commitments in the OGP National Action Plan for the January-December 2022 reporting period is also indicated visually in Table 1 based on the legend below. Where an activity has not yet started but is not delayed, then no status indicator is shown.
