Jamaica – Open Government Partnership (OGP): Second National Action Plan (NAP) 2024-2026

First Progress Report on Status of Implementation

June 2024 - June 2025

Prepared by: Ministry of Finance and the Public Service (MOFPS)

1. Background and Context

This is the first public progress report on the implementation of Jamaica's second National Action Plan (NAP) under the Open Government Partnership (OGP) process. The second OGP NAP 2024-2026 was approved by Cabinet by way of decision in October 2024, and was submitted to the OGP in December 2024, and is being implemented over the period from June 2024 – June 2026. This first public progress report covers the period June 2024 – June 2025, and discusses the progress made toward implementing the seven (7) commitments in the OGP NAP during this reporting period, which covers the first year of Jamaica's second action planning cycle under the OGP. The progress report has been prepared in line with the reporting requirements of the OPG process by the Ministry of Finance and the Public Service (MOFPS), as the lead ministry for the OGP process in Jamaica, and reviewed by the OGP Multi-Stakeholder Forum (MSF), based on information provided on the status of the seven (7) commitments in the OGP NAP by each of the seven (7) implementing ministries and agencies of the Government of Jamaica (GOJ), as follows:

2. Highlights of Progress

The progress report on the second OGP NAP indicates that progress is underway on all seven (7) commitments during the June 2024 – June 2025 review period, as highlighted below:

2.1 Complete National Anti-Corruption Strategy

The Integrity Commission has held consultations on the National Anti-Corruption Strategy (NAS) with select stakeholders during the period. A National Consultation with select stakeholders on the NAS was held in July 2024. Draft NAS is being articulated for further consultations.

2.2 Upgrade and Strengthen the Open Data System in Jamaica

The Draft Implementation Plan for the Open Data Policy has been completed and is being executed. Multiple communication and sensitization sessions on the Open Data Policy have been conducted with MDAs and other stakeholders.

2.3 <u>Amend the Access to Information (ATI) Act and Strengthen the ATI System in</u> Jamaica

The review of comments received from the Legal Reform Department and the Attorney General's Chambers on the draft Cabinet Submission for the proposed establishment of the new Joint Select Committee (JSC) of Parliament was completed during the period. Updated policy guidance has been requested. However, the preparation of a Draft Bill to amend the ATI Act and regulations remains delayed, contingent on Joint Select Committee establishment and review of the ATI Act and submissions made by stake holders. Meanwhile activities remain on track to prepare improved guidelines for public bodies and ATI officers, undertake capacity development and training for ATI officers, conduct programme of public education on the ATI system and rights, and strengthen reporting mechanisms for annual reports, and reporting for the SDGs and Lima Commitment.

2.4 <u>Increase Access to Information on and Public Awareness of the Justice System and Human Rights</u>

The Jamaica Legal Information Portal (JLIP) was successfully launched on July 30, 2025. Consultation and informal discussions were held with Jamaicans for Justice (JFJ) and agreement reached on galvanising the Public Education Programme around a Human Rights Colouring Book. The concept for the colouring and activity book was developed collaboratively with plans to roll out related educational programmes in primary schools on completion.

2.5 Complete Environmental Impact Assessment (EIA) Regulations

NEPA is in consultation on the elements of the EIA Regulations and has set a timeline for the end of the 3rd quarter 2025-2026 (December 2025) to finalise a submission to their parent ministry (MEGID).

2.6 <u>Update and Implement the Climate Change Policy Framework</u>

USAID had started to engage consultants, to support preparation of a Concept Paper in relation to climate change legislation and discussions had continued to finalize the TOR and concept. However, activities under the initiative were postponed generally but completely discontinued with the end of funding support from USAID. UK FCDO approached the government, and engagements resumed to progress initiatives under the assignment. There was a financial restructuring by the UK government including the funding available for FCDO work programme of activities in Jamaica. Confirmation was later received on the availability of funding to undertake the assignment, and new TOR and draft concept were finalized as per new development partner requirements. Discussions commenced with potential consultants.

Stakeholder consultations on Jamaica's Nationally Determined Contribution (NDC) for the Paris Agreement were conducted from April 2024 – May 2025, including Multi-Stakeholder Session on August 20, 2024, NDC Scenario Development Sessions on October 31, 2024, Youth Sensitization Workshop on November 1, 2024 and NDC Public Validation Session on May 27, 2025. The new and updated NDC was submitted in September 2025 and is now available on the NDC Registry of the UNFCCC. Details of the NDC were announced by the Prime Minister during UNGA 80 during a special UN SG event in New York.

2.7 Strengthen Youth Participation and Access to Services

The Implementation Plan and Monitoring and Evaluation Framework for the National Youth Policy has been reviewed but is not completed. The Jamaica Information Service (JIS) was contracted and the website for the Youth and Adolescents Policy Division was completed and launched on November 1, 2024, and continues to be updated. The complete Gap Analysis and Recommendations Report for the National Youth Programmatic Inventory was published for the launch of the website in November 2024. The National Youth Programmatic Inventory online directory was established in November 2024 with the launch of the website. Since then, the directory has been periodically updated to reflect the addition of new youth-serving programmes. The "Inspire Him, Inspire Her" is the programme designed to engage the unattached youths. It includes life skill training, job placement and entrepreneurship. The social intervention programme focuses on dispute resolution, anger management, parenting, etc.

A detailed report on the progress made and implementation status for each milestone activity under the seven (7) commitments in the second OGP NAP is provided in Table 1 below.

3. Key Issues and Challenges by Commitment

However, a number of activities are delayed based on the progress reporting, with a common theme of constraints in human resources and funding impacting their timely implementation. The following is a summary of the current key issues and challenges for timely implementation of each of the seven (7) commitments in Jamaica's second OGP NAP.

3.1 Complete National Anti-Corruption Strategy

Delay in development of Draft National Anti-Corruption Strategy.

3.2 Upgrade and Strengthen the Open Data System in Jamaica

There were challenges with the operationalisation of the back end to the updated Open Data Portal. A short term consultancy was conducted to fix this. Obtaining data from the MDAs continues to be a challenge.

3.3 <u>Amend the Access to Information (ATI) Act and Strengthen the ATI System in</u> Jamaica

Human resource challenges have been identified for the activities relating to the establishment of the Access to Information Act Advisory Committee, conducting a programme of public education on the ATI system and rights, and development of proposal for the application of technology for online platform for making and tracking ATI requests.

3.4 <u>Increase Access to Information on and Public Awareness of the Justice System and Human Rights</u>

With the merging of the Ministry of Justice and the Ministry of Legal and Constitutional Affairs, planned activities previously approved will need to be discussed within the new Ministry and are subject to review and approval.

3.5 Complete Environmental Impact Assessment (EIA) Regulations

Staffing constraints within the NEPA legal department have led to delays in executing the activities for this commitment.

3.6 <u>Update and Implement the Climate Change Policy Framework</u>

Funding for all USAID activities were discontinued including funding support for climate change legislation. Discussions had to restart with a new funding entity or development partner to assist with carrying out the assignment. Significant shifts are therefore expected in the timelines for the deliverables leading towards developing climate change legislation.

3.7 Strengthen Youth Participation and Access to Services

The Implementation Plan requires a multi-sectoral collaboration and approach, which is sometimes difficult to execute. There has also been slow uptake from youth-serving organisations to complete the Programmatic Inventory form.

4. Dashboard of Milestone Activity Implementation Status

The status of implementation of the milestone activities for each of the seven (7) commitments in the second OGP National Action Plan for the June 2024 – June 2025 reporting period is also indicated visually in Table 1 based on the legend below. Where an activity has not yet started but is not delayed, then no status indicator is shown.
